Pursuant to Article 37(2) and Article 65(5) of the Law on Protection of Competition (Official Gazette of the RS 51/09 and 95/13), and Article 2(1/6) of the Tariff on the level of compensations for activities within the competence of the Commission for Protection of Competition (Official Gazette of the RS 49/11), deciding under the notification of concentration entered under number 6/0-02-541/2018-1 of July 16, 2018, submitted by companies Thyssenkrupp Technologies Beteiligungen GmbH, with registered seat at the address Thyssenkrupp Allee 1 45143, Essen, Germany, and Orchid Netherlands (No. 1) B.V., with registered seat at the address Wenckebachstraat 1, 1951 JZ Velsen-Noord, the Netherlands, via a procurator holder, attorney at law Bojana Miljanović from the Law Office of Karanović and Nikolić from Belgrade, 23 Resavska St., on August 15, 2018, member of the Council of the Commission for Protection of Competition acting upon the authority granted by the Commission President no. 1/0-06-119/2018-2 of January 8, 2018 enacts the following

DECISION

I Concentration of undertakings in summary procedure **IS APPROVED** created by entering into a joint venture by companies Thyssenkrupp Technologies Beteiligungen GmbH, with registered seat at the address Thyssenkrupp Allee 1 45143, Essen, Germany, company number HRB 21754, and Orchid Netherlands (No. 1) B.V., with registered seat at the address Wenckebachstraat 1, 1951 JZ Velsen-Noord, the Netherlands, company number 343 31 611, by integrating the flat carbon steel operations of ThyssenKrupp Group and Tata Steel Group, including the steel mill operations of ThyssenKrupp Group, into company ThyssenKrupp Netherlands Project B.V., with registered seat at the address Taylorweg 7, 5466 AE Veghel, the Netherlands, which will conduct its future operations under business name ThyssenKrupp Tata Steel B.V.

II IT IS ESTABLISHED that the Party, Orchid Netherlands (No. 1) B.V., with registered seat in the Netherlands, has executed payment in the amount of EUR 12,500.00 (in words: twelve thousand, five hundred and 00/100 euro) on July 20, 2018, and that the Party, company Thyssenkrupp Technologies Beteiligungen GmbH, with registered seat in Germany, has executed payment in the amount of EUR 12,500.00 (in words: twelve thousand, five hundred and 00/100 euro) on July 25, 2018 to the account of the Commission for Protection of Competition, which in

total represents stipulated amount of the fee as compensation for issuing decision on approval of concentration in summary procedure.
