Pursuant to Article 37(2) and Article 65(5) of the Law on Protection of Competition (Official Gazette of the RS 51/09 and 95/13), and Article 2(1/6) of the Tariff on the level of compensations for activities within the competence of the Commission for Protection of Competition (Official Gazette of the RS 49/11), deciding under the notification of concentration entered under number 6/0-02-581/2018-1 of July 30, 2018, submitted by company NEPT Holdings S.à.r.l., with registered seat at the address 124, Boulevard de la Petrusse, office 404, L-2330, Luxembourg, via procurator holder, attorney at law Raško Radovanović from the Law Office „Petrikić & Parnets“ from Belgrade, 73 Krunska St., on August 24, 2018, a member of the Council of the Commission for Protection of Competition acting upon the authority granted by the Commission President no. 1/0-06-119/2018-2 of January 8, 2018, enacts the following

DECISION

I Concentration of undertakings in summary procedure **IS APPROVED** created by acquisition of joint control on the part of company NEPT Holdings S.à.r.l., incorporated and operating in accordance with the legislation of Luxembourg, with registered seat at the address 124, Boulevard de la Petrusse, office 404, L-2330, Luxembourg, company number B226560, foundation Luski Foundation, founded and operating in accordance with the legislation of Liechtenstein, with registered seat at the address Herrengasse 6, 9490 Vaduz, Liechtenstein, registration number FL-0002.374.904 2, Mr. Mirio Troi, Italian citizen, passport no. YA7888479, residing at the address Via Sabotino 24, 33100 Udine, Italy, Mr. Enrico Accettola, Italian citizen, passport no. YA3708013, residing at the address Via Bonaldo Stringher 1, 33100 Udine, Italy, Mr. Dominik Sliwowski, Polish citizen, passport no. EF 3255143, residing at the address ul. II IT IS ESTABLISHED that the Party has executed payment in the amount of RSD 2,951,547.50 (in words: two million, nine hundred fifty-one thousand, five hundred forty-seven and 50/100 dinars) on August 3, 2018, to the account of the Commission for Protection of Competition, which represents a stipulated amount of the fee as compensation for issuing decision on approval of concentration in summary procedure.
