Pursuant to Article 37(2) and Article 65(5) of the Law on Protection of Competition (Official Gazette of the RS 51/09 and 95/13), and Article 2(1/6) of the Tariff on the level of compensations for activities within the competence of the Commission for Protection of Competition (Official Gazette of the RS 49/11), deciding under the Notification of concentration entered under number 6/0-02-625/2018-1 of August 28, 2018, jointly submitted by companies Adient Global Holdings Ltd., with registered seat at the address 2nd floor, Gaspé House, 66-72 Esplanade JE1 1GH St. Helier, Jersey, USA, and Yanfeng Automotive Interior Systems Kft, with registered seat at the address Juhar utca 17, 85000 Papa, Hungary, via procurator holder, attorney at law Srđana Petronijević from the Law Office of Moravčević, Vojnović and Partners from Belgrade, 15 Dobračina St., on September 24, 2018, President of the Commission for Protection of Competition enacts the following

DECISION

I Concentration of undertakings in summary procedure **IS APPROVED** created by acquisition of joint control by changing the form of control from individual into joint, executed on the part of company Adient Global Holdings Ltd., company number 121385, with registered seat at the address 2nd floor, Gaspé House, 66-72 Esplanade JE1 1GH St. Helier, Jersey, USA, and company Yanfeng Automotive Interior Systems Kft, incorporated in accordance with the legislation of Hungary under company number 01-09-196602, with registered seat at the address Juhar utca 17, 85000 Papa, Hungary, over company Adient Interiors d.o.o. Kragujevac, Serbia, company number 20736917, with registered seat at the address 4 Kosovska St., Kragujevac, Republic of Serbia, created by purchasing 50% of shares in this company by Yanfeng Automotive Interior Systems Kft.

II IT IS ESTABLISHED that the Parties, company Adient Global Holdings Ltd., with registered seat at the address 2nd floor, Gaspé House, 66-72 Esplanade JE1 1GH St. Helier, Jersey, USA, and company Yanfeng Automotive Interior Systems Kft, with registered seat at the address Juhar utca 17, 85000 Papa, Hungary, have executed payment in the amount of RSD 2,961,757.50 (in words: two million, nine hundred sixty-one thousand, seven hundred fifty-seven and 50/100 dinars) on September 12, 2018, to the account of the Commission for Protection of Competition, which represents a stipulated amount of the fee as compensation for issuing decision on approval of concentration in summary procedure.
