Pursuant to Article 37(2) and Article 65(5) of the Law on Protection of Competition (Official Gazette of the RS 51/09 and 95/13), and Article 2(1/6) of the Tariff on the level of compensations for activities within the competence of the Commission for Protection of Competition (Official Gazette of the RS 49/11), deciding under the notification of concentration entered under number 6/0-02-706/2018-1 of October 3, 2018, jointly submitted by natural persons Nebojša Šaranović from Belgrade, 8 Lackovićeve St., Nebojša Janković from Belgrade, 068/4/13 Arsenija Čarnojevića Blvd., Dejan Dragojević from Belgrade, 053/5/15 Skender Begova St., and Martin Kammermeier residing in Vienna, Republic of Austria, at the address Sieveringstrasse 32a, via procurator holder, attorney at law Nataša Zavišin from the Law Office of Zavišin Semiz and Partners, 18 Simina St., Belgrade, on November 22, 2018, President of the Commission for Protection of Competition enacts the following

DECISION

I Concentration of undertakings in summary procedure **IS APPROVED** created by changing the number of members executing a joint control over company NDM Asset Ression d.o.o. Beograd, with registered seat at the address 36 Kneza Aleksandra Karađorđevića Blvd., Belgrade, company number 21396923, by acquiring joint control over said company on the part of natural persons Nebojša Šaranović from Belgrade, 8 Lackovićeve St., Nebojša Janković from Belgrade, 068/4/13 Arsenija Čarnojevića Blvd., Dejan Dragojević from Belgrade, 053/5/15 Skender Begova St., and Martin Kammermeier residing in Vienna, Republic of Austria, at the address Sieveringstrasse 32a, and by acquiring indirect joint control via this company over Heta Asset Resolution d.o.o. Beograd, a company incorporated in the Republic of Serbia, company number 20119497, with registered seat at the address 115g Mihajla Pupina Blvd., New Belgrade, and its subsidiaries, created by the acquisition of 100% of shares in Heta Asset Resolution on the part of NDM Asset Ression d.o.o. Beograd as a special-purpose vehicle, from the previous owner, company HAR GmbH, Klagenfurt, Austria.

II IT IS ESTABLISHED that company NDM Asset Management d.o.o. Beograd-Savski venac, 36 Kneza Aleksandra Karađorđevića Blvd., has executed payment in the amount of RSD 2,966,337.50 (in words: two million, nine hundred sixty-six thousand, three hundred thirty-seven and 50/100 dinars) on October 8, 2018, to the account of the Commission for Protection of Competition, which represents a stipulated amount of the fee as compensation for issuing decision on approval of concentration in summary procedure.
