Pursuant to Article 22(2) of the Law on Protection of Competition (Official Gazette of the RS 51/2009 and 95/2013), and Article 2(1/2) of the Tariff on the level of compensations for activities within the competence of the Commission for Protection of Competition (Official Gazette of the RS 49/2011), deciding under the Request for individual exemption of restrictive agreement from the prohibition - Manufacturing Services Agreement, submitted by companies AD Industrija mleka i mlečnih proizvoda IMLEK, with registered seat at the address bb Industrijsko naselje St., Padinska Skela, Belgrade, whose legal representative is Bojan Radun, CEO, company number 07042701, and MEGGLE Srbija doo Kragujevac, with registered seat at the address 58 Save Kovačevića St., Kragujevac, whose legal representative is Aleksandar Nedeljković, CEO, company number 07150512, whose joint procuration holders are attorney at law Dragan Karanović and others from the Law Office Karanović Partners, with registered seat at the address 23 Resavska St., Belgrade, at the 171<sup>st</sup> session of the III convocation held on October 31, 2018, the Council of the Commission for Protection of Competition enacts the following

## **DECISION**

- I Restrictive agreement Manufacturing Services Agreement IS EXEMPT FROM THE PROHIBITION, concluded on October 16, 2018 between companies AD Industrija mleka i mlečnih proizvoda IMLEK, with registered seat at the address bb Industrijsko naselje St., Padinska Skela, Belgrade, company number 07042701, and MEGGLE Srbija doo Kragujevac, with registered seat at the address 58 Save Kovačevića St., Kragujevac, company number 07150512.
- II TIME PERIOD IS SET pertaining to the individual exemption from the prohibition of restrictive agreement from Paragraph I of enacting terms herein, in the duration of 6 months from the date of application of the Agreement concerned, that is, until April 16, 2019.
- III Commitment **IS ESTABLISHED** and **IT IS ORDERED** to the Parties to execute payment as compensation for issuing this Decision in dinar-currency equivalent value of EUR 1,200.00, calculated at the middle exchange rate of the National Bank of Serbia on the day of payment, to the account of the Commission for Protection of Competition no. 840-0000000880668-16 maintained with the Treasury Administration, with reference number 4/0-03-745/2018, no later than seven days from the date of receipt of this Decision.

It is established that the Parties have executed respective payment on October 30, 2018 in the amount of RSD 142,017.12, thus have acted in line with their commitment as defined herein.
