Pursuant to Article 37(2) and Article 65(5) of the Law on Protection of Competition (Official Gazette of the RS 51/09 and 95/13), and Article 2(1/6) of the Tariff on the level of compensations for activities within the competence of the Commission for Protection of Competition (Official Gazette of the RS 49/11), deciding under the merger notification entered under number 6/0-02-762/2018-1 of October 31, 2019, submitted by company Liberty Steel East Europe (Bidco) Limited, with registered seat at the address 7 Hertford Street, London, UK, W1J 7RH, United Kingdom of Great Britain and Northern Ireland, via procurator holder Bojana Miljanović and other attorneys at law from the Law Office Karanović & Nikolić, 23 Resavska St., Belgrade, on January 14, 2019, a member of the Council of the Commission for Protection of Competition acting under the authority granted by the Commission President no. 1/0-06-168/2019-2 of January 8, 2019, enacts the following

## **DECISION**

**I** Concentration of undertakings in summary procedure **IS APPROVED** created by acquisition of control on the part of company Liberty Steel East Europe (Bidco) Limited, with registered seat at the address 7 Hertford Street, London, UK, W1J 7RH, United Kingdom of Great Britain and Northern Ireland, company number 11605518, over certain business operations and assets of company ArcelorMittal Holdings AG, with registered seat at the address Alpenstrasse 15, 6304 Zug, Switzerland, company number CHE-112.701.185, consisting of the following companies: CBA Steel Limited, with registered seat at the address Seventh Floor, Berkeley Square, London, UK, W1J 6DA, United Kingdom of Great Britain and Northern Ireland, company number 11680699; Paloma S.r.l., with registered seat at the address 34 via Portovecchio, Piombino (LI), Italy, company number 01883410498; and, ArcelorMittal Ostrava a.s., with registered seat at the address Vratimovská 689/117, Kunčice, 719 00 Ostrava, Doručovací číslo: 70702, Czech Republic, company number 45193258, and four distribution centers in Arcore, Rieti, Quarto Inferiore and Graffignana, Italy, by purchasing 100% of shares in CBA Steel Limited, Paloma S.r.l. и ArcelorMittal Ostrava a.s., and said business units corresponding to the abovementioned distribution centers and identified in Article 3 of the Draft Agreement on purchase and sale of business units.

**II IT IS ESTABLISHED** that the party has made payment in the amount of EUR 25,000.00 (in words: twenty-five thousand euro) on November 5, 2018, into the account of the Commission for Protection of Competition, which represents a stipulated amount of the fee as compensation for issuing decision on the approval of concentration in summary procedure.
