Pursuant to Article 37(2) and Article 65(5) of the Law on Protection of Competition (Official Gazette of the RS 51/09 and 95/13), and Article 2(1/6) of the Tariff on the level of compensations for activities within the competence of the Commission for Protection of Competition (Official Gazette of the RS 49/11), deciding under the merger notification entered under number 6/0-02-328/2019-1 of April 5, 2019, jointly submitted by companies SA Sogclair, with registered seat at the address 7 Avenue Albert Durand, Zone aéroportuaire, 31703 Blagnac, France, and SAS AddUp, with registered seat the address 5 rue Bleue, Zone Industrielle de Ladoux, 63118 Cébazat, France, via procurator holder, attorney at law Danijel Stevanović from the Law Office “Moravčević Vojnović i partneri” from Belgrade, 15 Dobračina St., on May 29, 2019, a member of the Council of the Commission for Protection of Competition acting under the authority granted by the Commission President no. 1/0-06-168/2019-2 of January 8, 2019, enacts the following

DECISION

I Concentration of undertakings in summary procedure **IS APPROVED** created by acquisition of joint control on the part of company SA Sogclair, Toulouse Corporate Register number 335 218 269, with registered seat at the address 7 Avenue Albert Durand, Zone aéroportuaire, 31703 Blagnac, France, and SAS AddUp, Clermont-Ferrand Corporate Register number 819 409 939, with registered seat the address 5 rue Bleue, Zone Industrielle de Ladoux, 63118 Cébazat, France, over a newly founded joint venture company PrintSky, with registered seat in Toulouse, France.

II IT IS ESTABLISHED that the parties, company SA Sogclair, company number 335 218 269, with registered seat at the address 7 Avenue Albert Durand, Zone aéroportuaire, 31703 Blagnac, France, and company Predica Prevoyance Dialogue du Credit Agricole SA, company number 334 028 123, have made payment in the amount of RSD 1,474,418.75 (in words: one million four hundred seventy-four thousand four hundred eighteen and 75/100 dinars) on May 16, 2019, and the amount of RSD 1,474,388.75 (in words: one million four hundred seventy-four thousand three hundred eighty-eight and 75/100 dinars) on May 24, 2019, into the account of the Commission for Protection of Competition, which represents a stipulated amount of the fee as compensation for issuing decision on the approval of concentration in summary procedure.
