Pursuant to Article 37(2) and Article 65(5) of the Law on Protection of Competition (Official Gazette of the RS 51/09 and 95/13), and Article 2(1/6) of the Tariff on the level of compensations for activities within the competence of the Commission for Protection of Competition (Official Gazette of the RS 49/11), on receipt of the merger notification No. 6/0-02-595/2019-1 of June 28, 2019, submitted by company KKR & Co. Inc., with main corporate office at the address 9 West 57th Street, Suite 4200, New York, NY-10019, Unites States of America, and Charles Dime, Canadian citizen, via procuracy holder, Maja Stanković and other attorneys at law from the Law Office WOLF THEISS from Belgrade, BC Ušće, 6 Mihajla Pupina Blvd., on July 29, 2019, a member of the Council of the Commission for Protection of Competition acting under the authority granted by the Commission President No. 1/0-06-168/2019-2 of January 8, 2019, enacts the following

DECISION

I Concentration of undertakings in summary procedure **IS APPROVED**, created by acquisition of joint control on the part of company KKR & Co. Inc., with main corporate office at the address 9 West 57th Street, Suite 4200, New York, NY-10019, Unites States of America, company number 4378294, via subsidiary company LGC Standards Canada Limited, with registered seat at the address 151 Yonge Street, Suite 1500, Toronto, Ontario M5C2W7, Canada, company number 002705585, and Charles Dime, Canadian citizen, holding 75% and 25% of shares respectively, over company Biomed Pharmaceutical Limited, with registered seat at the address 2 Brisbane Road, North York, Ontario, M3J2J8, Canada, company number 000793129, its subsidiary company Toronto Research Chemicals Inc., with registered seat at the address 108 Isabella Street, 1018, Toronto, Ontario, M4YIN6, Canada, company number 568064, and company Synfine Research Limited, with registered seat at the address 200 King Street West, Suite 2300, Toronto, Ontario, M5H3W5, Canada, company number 1269183, acquired by purchasing 75% shares in companies Biomed and Synfine on the part of LGC Standards Canada Limited from the current two-party joint control holders, Charles Dime and David Dime, holding 50% of shares each.
