DECISION

I Concentration of undertakings in summary procedure **SHALL BE APPROVED**, created by acquisition of direct joint control on the part of companies PPF BEER TOPHOLDCO B.V., with registered office at Strawinskylaan 933, 1077 XX Amsterdam, the Netherlands, company registration number 67420427, and EXSA EXPORT SANAYI MAMULLERI SATIŞ VE ARAŞTIRMA A.Ş., with registered office at Konaklar Mahallesi, Selvili Sokak, Sabanci Center Kule 2 No:2/1 Beşiktaş, Istanbul, Turkey, company registration number 574854-0, over company Temsa Ulaşım Araçları Sanayi ve Ticaret A.Ş., with registered office at Sarihamzali Mahallesi, Turhan Cemal Beriker Bulvari No.563/A Seyhan/Adana, Turkey, company registration number 6205, and its subsidiaries, by purchasing shares.
