## **DECISION**

**I** Concentration of undertakings in summary procedure **SHALL BE APPROVED**, created by acquisition of indirect joint control on the part of company Bain Capital Investors, LLC, with registered office at 200 Clarendon Street, Boston, MA 02116, United States of America, and company Carlyle Group L.P., with registered office at 1001 Pennsylvania Avenue, NW Washington, DC 20004, United States of America, via their jointly managed company Luz (C-BC) Bidco GmbH, with registered office at Maximilianstr. 11, 80539 Munich, Germany, registered in the Commercial Register maintained at the Municipal Court of Munich under company number HRB 247053, over company OSRAM Licht AG, with registered office at Marcel-Breuer-Str. 6, 80807 Munich, Germany, registered in the Commercial Register maintained at the Municipal Court of Munich under company number HRB 199675.

**II IT SHALL BE ESTABLISHED** that the parties, companies Bain Capital Investors, LLC and Carlyle Group L.P., have made payment in the amount of XXX euro on August 8, 2019, and XXX euro on August 9, 2019, respectively, into the account of the Commission for Protection of Competition, which in total represents the fee charged for issuing a merger clearance decision in summary procedure.
