Pursuant to Article 37(2) and Article 65(5) of the Law on Protection of Competition (Official Gazette of the RS 51/09 and 95/13), and Article 2(1/6) of the Tariff on the level of compensations for activities within the competence of the Commission for Protection of Competition (Official Gazette of the RS 49/11), in proceedings instituted on receipt of the merger notification No. 6/0-02-486/2020-1 of July 1, 2020, filed by companies Javno preduzeće Elektroprivreda Srbije Beograd (Stari Grad), with registered office at 13 Balkanska St., Belgrade, Republic of Serbia, and Mješoviti holding “Elektroprivreda Republike Srpske” – Matično preduzeće, akcionarsko društvo Trebinje, with registered office at bb Stepe Stepanovića St., Trebinje, Republika Srpska, Bosnia and Herzegovina, represented by procurator holder Srđana Petronijević, an attorney at law from Belgrade, 6-8 Vojvode Bojića Blvd., on July 22, 2020, the President of the Commission for Protection of Competition enacts the following

DECISION

I Concentration of undertakings in summary procedure **SHALL BE APPROVED**, created by acquisition of joint control on the part of companies Javno preduzeće Elektroprivreda Srbije Beograd (Stari Grad), with registered office at 13 Balkanska St., Belgrade, Republic of Serbia, company number 20053658, and Mješoviti holding “Elektroprivreda Republike Srpske” – Matično preduzeće, akcionarsko društvo Trebinje, with registered office at bb Stepe Stepanovića St., Trebinje, Republika Srpska, Bosnia and Herzegovina, company number 01756192, over company “Hidroelektroenergetski sistem Gornja Drina” društvo sa ograničenom odgovornošću za proizvodnju i prodaju električne energije Foča, with registered office at 19 Nemanjina St., Foča, Republika Srpska, Bosnia and Herzegovina, company number 11171222, by making pecuniary contributions and acquiring [...] of shares in said company on the part of Javno preduzeće Elektroprivreda Srbije Beograd (Stari Grad), while its previous sole shareholder Mješoviti holding “Elektroprivreda Republike Srpske” – Matično preduzeće, akcionarsko društvo Trebinje will keep [...] of shares.
