Pursuant to Article 37(2) and Article 65(5) of the Law on Protection of Competition (Official Gazette of the RS 51/09 and 95/13), and Article 2(1/6) of the Tariff on the level of compensations for activities within the competence of the Commission for Protection of Competition (Official Gazette of the RS 49/11), in proceedings instituted on receipt of the Merger notification No. 6/0-02-738/2020-1 of December 3, 2020, filed by company TATRAVAGÓNKA a.s., with registered office at Štefánikova 887/53, 058 01 Poprad, Slovakia, via procuration holder Dragan Gajin, an attorney at law from the Law Office of Doklestić Repić & Gajin, 4 Petra Kočića St., Belgrade, on December 25, 2020, the President of the Commission for Protection of Competition enacts the following

DECISION

I Concentration of undertakings in summary procedure **SHALL BE APPROVED**, created by acquisition of individual control on the part of company TATRAVAGÓNKA a.s., with registered office at Štefánikova 887/53, 058 01 Poprad, Slovakia, company registration number 31699847, over company ŽOS Vrútky a.s., with registered office at Dielenská Kružná 2, 038 61 Vrútky, Slovakia, company registration number 31 615 619, by purchasing shares, as well as by acquisition of joint control over companies ŽOS-EKO, s.r.o., with registered office at Dielenská Kružná 2, 038 61 Vrútky, Slovakia, company registration number 36 002 445, ŽOS-MEDIKA, s.r.o., with registered office at Dielenská Kružná 2, 038 61 Vrútky, Slovakia, company registration number 36 006 203, and ŽOS TRADING s.r.o., with registered office at Dielenská Kružná 2, 038 61 Vrútky, Slovakia, company registration number 31 574 653, by purchasing shares from the former co-owner of these companies, where the other co-owner of these companies, to jointly execute control with company TATRAVAGÓNKA a.s., remains unchanged.

II **IT SHALL BE ESTABLISHED** that the notifying party, TATRAVAGÓNKA a.s., had made payment in the amount of XXX (XXX) euro on December 8, 2020 into the account of the Commission for Protection of Competition, which represents the fee charged for issuing a merger clearance decision in summary procedure.
