DECISION

I Concentration of undertakings in summary procedure **SHALL BE APPROVED**, created by acquisition of control on the part of companies J. Christof E&P Services S.R.L., with registered office at Brazii de Sus Village, Brazi Commune, 49A Trandafirilor St., Prahova County, Romania, company registration number J29/1314/2009, and Christof Private Firefighting Services S.R.L., with registered office at Brazii de Sus Village, Brazi Commune, 49A Trandafirilor St., Office No. 0 90814363 2013058/212-JCRC-9000146, Prahova County, Romania, company registration number J29/2428/2019, over business operations of company OMV Petrom S.A., with registered office at 22 Coralilor St., Petrom City, 1st District, Bucharest, Romania, company registration number J40/8302/1997, relating to several operations and general surface services, ancillary to extraction of petroleum and natural gas in the territory of Romania.
