Pursuant to Article 22(2), Article 25(1), Article 57(1), and Article 68(1/4) of the Law on Protection of Competition (Official Gazette of the RS 51/09 and 95/13), and Articles 3 and 4 of the Regulation on criteria for setting the amount payable on the basis of measure for protection of competition and sanctions for procedural breaches, manner and terms for payment therein and conditions for determination of respective measures (Official Gazette of the RS 50/10), in proceedings *ex officio* brought against company Fortenova Grupa d.d, with registered office at 1 Marijana Čavića St., Zagreb, Republic of Croatia, company number 081179147, represented by Tijana Kojović from the Law Office "BDK Advokati", 28 Kralja Aleksandra Blvd., Belgrade, to investigate the permissibility of concentration implemented prior to obtaining clearance under the Law on Protection of Competition, at the 40<sup>th</sup> Session held on February 12, 2021, the Council of the Commission for Protection of Competition enacts the following

## **DECISION**

- I T SHALL BE ESTABLISHED that a concentration created by acquisition of individual control on the part of company Fortenova Grupa d.d, with registered office at 1 Marijana Čavića St., Zagreb, Republic of Croatia, company number 081179147, over companies:

- **IT SHALL BE ESTABLISHED** that concentration referred to in Paragraph I of enacting terms herein fulfils the requirements of permissibility in accordance with Article 19 of the Law on Protection of Competition.
- MEASURE FOR PROTECTION OF COMPETITION SHALL BE DETERMINED III against undertaking, company Fortenova Grupa d.d, with registered office at 1 Marijana Čavića St., Zagreb, Republic of Croatia, company number 081179147, in the form of a commitment to pay a monetary sum in the amount of RSD 8,820,000.00 (in words: eight million eight hundred twenty thousand dinars).
- IV IT SHALL BE ORDERED to undertaking, company Fortenova Grupa d.d, with registered office at 1 Marijana Čavića St., Zagreb, Republic of Croatia, company number 081179147, to execute payment in respect of the measure for protection of competition referred to in Paragraph III of enacting terms herein to the Budget account of the Republic of Serbia, No. 840 743224 843 94 MOD 97 - with Reference number: two-digit control number MOD 97 – three-digit number of the municipality, city or area – number of this decision.
- **DEADLINE SHALL BE SET OUT** for undertaking, company Fortenova Grupa d.d, with registered office at 1 Marijana Čavića St., Zagreb, Republic of Croatia, company number 081179147, at 3 (three) months from the notification of this Decision to execute orders referred to in Paragraph IV of enacting terms herein, under threat of enforcement measures implemented by the Tax Administration under regulations governing tax collection.
- VI IT SHALL BE ORDERED to undertaking, company Fortenova Grupa d.d, with registered office at 1 Marijana Čavića St., Zagreb, Republic of Croatia, company number 081179147, that no later than 5 (five) days from the date of execution of orders referred to in Paragraph V of enacting terms herein, to submit proof of payment thereof to the Commission for Protection of Competition.
