## **DECISION**

**I** Concentration of undertakings in summary procedure **SHALL BE APPROVED**, formed by merger of companies Peugeot S.A., with registered office at 7 Rue Henri Sainte – Claire Deville, 92563 Rueil – Malmaison, France, company number SIRET 55210055400047, with company Fiat Chrysler Automobiles N.V., with registered seat in Amsterdam, the Netherlands, and the principal executive offices at 25 St James's Street, London, SW1A 1HA, UK, registered in the Companies House under number FC031853, by incorporating a new company DutchCo resulting from the merger.
