The President of the Commission for Protection of Competition, pursuant to Article 37(2) and Article 65(5) of the Law on Protection of Competition (“Official Gazette of the RS”, Nos. 51/09 and 95/13) and Article 2(1/6) of the Tariff on the level of compensations for activities within the competence of the Commission for Protection of Competition (“Official Gazette of the RS”, No. 49/11), in proceedings instituted on receipt of Merger notification No. 6/0-02-556/2021-1 of July 9, 2021, filed by Balkan Commodities d.o.o., having its registered office address at 6-8 Bulevar vojvode Bojovića Blvd., Belgrade, Republic of Serbia, thought its legal representative, attorney at law Danijel Stevanović from Belgrade, 6-8 Bulevar vojvode Bojovića Blvd., on August 31, 2021, enacts the following

DECISION

I Concentration of undertakings in summary procedure **SHALL BE APPROVED**, created by acquisition of individual control on the part of Balkan Commodities d.o.o., having its registered office address at 6-8 Bulevar vojvode Bojovića Blvd., Belgrade, Republic of Serbia, company number 21698792, over the following companies: GRANEXPORT DOO PANČEVO, having its registered office address at 5 Luka Dunav, Pančevo, Republic of Serbia, company number 07061641; LUKA-BAČKA PALANKA D.O.O., having its registered office address at 35 Industrijska zona, Bačka Palanka, Republic of Serbia, company number 08760233; and, DOO ŽITO-BAČKA KULA, having its registered office address at 17 Josipa Kramera St., Kula, Republic of Serbia, company number 08004293, including the assets of AGROGLOBE DOO NOVI SAD, having its registered office address at 60 Bulevar oslobođenja Blvd., Novi Sad, company number 08827893, which includes [...] silos and business operations of this company that concerns the trade in grains and oilseeds.
