The President of the Commission for Protection of Competition, pursuant to Article 37(2) and Article 65(5) of the Law on Protection of Competition (“Official Gazette of the RS”, Nos. 51/09 and 95/13) and Article 2(1/6) of the Tariff on the level of compensations for activities within the competence of the Commission for Protection of Competition (“Official Gazette of the RS”, No. 49/11), in proceedings instituted on receipt of Merger notification No. 6/0-02-545/2021-1 of July 6, 2021, filed by Generali Asia N.V., having its registered office address at Alpha Tower, 20th Floor, De entree 91, Amsterdam, the Netherlands, thought its legal representative, attorney at law Nikola Poznanović from the Law Office “Janković Popović Mitić”, 6 Vladimira Popovića St., Belgrade, on August 2, 2021, enacts the following

DECISION

I Concentration of undertakings in summary procedure **SHALL BE APPROVED**, created by the acquisition of individual control on the part of Generali Asia N.V., having its registered office address at Alpha Tower, 20th Floor, De entree 91, Amsterdam, the Netherlands, company number 34118449, over the following companies: AXA AFFIN General Insurance Berhad, having its registered office address at Ground Floor, Wisma Boustead, 71, Jalan Raja Chulan, Kuala Lumpur, Wilayah Persekutuan, Malesia, company number 197501002042 (23820-W); AXA AFFIN Life Insurance Berhad, having its registered office address at Chulan Tower 3 (8th Floor), Jalan Conlay, Kuala Lumpur, Wilayah Persekutuan, Malesia, company number 200601003992 (723739-W); and, MPI Generali Insurans Berhad, having its registered office address at Menara Multi-Purpose, Capital Square, 8 Jalan Munshi Abdullah (8th Floor), Kuala Lumpur, Malesia, company registration number 197301001061 (14730-X), by way of purchase of shares.
