President of the Commission for Protection of Competition, pursuant to Article 37 paragraph 2 and Article 65 paragraph 5 of the Law on Protection of Competition (“Official Gazette of the Republic of Serbia”, number 51/09 and 95/13) and Article 2 paragraph 1 item 6) of the Tariff on the level of compensations for activities within the competence of the Commission for Protection of Competition (“Official Gazette of the RS”, No. 49/11), in deciding on the concentration notification number 6/0-02-749/2021-1, submitted on November 8, 2021 by Agri Europe Cyprus Limited with seat at the Oval, Office 502, Krinou 3, 4103 Agios Athanasios, Limassol, Cyprus, through the holder of the Power of Attorney lawyer Anja Tasić, from Radovanović, Stojanović & Partners AOD, 10b/5 Kralja Milana Street, on December 1, 2021, adopts the following

DECISION

I APPROVING in summary procedure, the concentration of market participants resulting from the acquisition of individual control by Agri Europe Cyprus Limited, with its registered office at The Oval, Office 502, Krinou 3, 4103 Agios Athanasios, Limassol, Cyprus, registration number NE 283435, over companies Sberbank dd, with its registered office at Varšavska 9, Zagreb, Croatia, registration number 080126398, Sberbank BH dd Sarajevo, with its registered office at Fra Anđela Zvizdovića 1, Sarajevo, Bosnia and Herzegovina, registration number 65-02-0023-11, Sberbank ad Banja Luka, headquartered at Jevrejska 71, Banja Luka, Bosnia and Herzegovina, registration number 1-10523-00, Sberbank Magyarorszag Zrt., Headquartered at Rákóczi út 1-3, Budapest, Hungary, registration number 01-10- 041720, Sberbank Serbia ad Beograd, with its registered office at Bulevar Mihaila Pupina 165g, Belgrade, Republic of Serbia, registration number 07792247, and Sberbank banka dd, with its registered office at Dunajska 128a, Ljubljana, Slovenia, registration number 5496527000, by purchasing shares.

IIIT SHALL BE ESTABLISHED that the notifying party, Agri Europe Cyprus Limited, paid the amount of RSD XXX, on November 10, 2021 to the account of the Commission for Protection of Competition, representing appropriate regulated amount for the issuance of decision on concentration approval in summary procedure according to the middle exchange rate of the National Bank of Serbia on payment date.
