President of the Commission for Protection of Competition, pursuant to Article 37 paragraph 2 and Article 65 paragraph 5 of the Law on the Protection of Competition (“Official Gazette of the Republic of Serbia”, no. 51/09 and 95/13), Article 2 paragraph 1 Item 6) of the Tariff on the level of compensations for activities within the competence of the Commission for Protection of Competition (“Official Gazette of the RS”, No. 49/11), in deciding upon notification on concentration number 6/0-02-221/2022-1, submitted on 10 January 2022 by companies Banca 5, S.p.A. with seat at Via Bisceglie 120, Milan, Italy, and Enel X S.r.l. with seat at Viale Tor di Quinto 45/47, 00191 Rome, Italy, through their holder of power of attorney, lawyer Danijel Stevanović, from law partnership “Moravčević, Vojnović and Partners”, from Belgrade, 6-8 Bulevar vojvode Bojovića Street, on 21. February 2022, adopts the following

DECISION

I APPROVING in summary procedure the concentration of market participants from obtaining common control by Banca 5 S.p.A. with seat at Via Bisceglie 120, Milan, Italy, registration number 05435910962, and Enel X S.r.l. with seat at Viale Tor di Quinto 45/47, 00191 Rome, Italy, with registration number 09945270966, over Mooney Group S.p.A. with seat at Via Privata Nino Bonnet 6A, Milan, Italy, registration number 10387140964 and its subsidiaries, by way of share purchase, and over the following companies, through Mooney Group S.p.A.: 1) PayTipper S.p.A, with seat at Via Marco D'Aviano 2, Milan MI, Italy, registration number 15844561009, 2) CityPoste Payment S.p.A. with seat at Via Pascoli Snc, Mosciano Sant'Angelo TE, Italy, registration number 01806800676, 3) Enel X Financial Services S.r.L with seat at Viale Di Tor Di Quinto 45/47, Rome RM Italy, registration number 15844561009, and 4) Junia Insurance S.r.L. with seat at Via Pascoli Snc, Mosciano Sant'Angelo TE, Italy, registration number 01955070675, and its subsidiaries, by way of share purchase.
