DECISION

I APPROVING in summary procedure, the concentration of market participants resulting from the acquisition of individual control by the company DRUSHTVO ZA EXPORT-IMPORT, WHOLESALE AND RETAIL TRADE IN TEXTILES AND CONFECTIONS FASHION COMPANY LIMITED LIABILITY COMPANY (DRUŠTVO ZA EXPORT-IMPORT, TRGOVINU NA VELIKO I MALO TEKSTILOM I KONFEKCIJOM FASHION COMPANY DRUŠTVO ZA OGRANIČENOM ODGOVORNOŠĆU), seated at Bulevar Mihaila Pupina 115b, Novi Belgrade, Republic of Serbia, ID number 06737536, over the company MOVEM & CO DOO BEOGRAD, seated at 22/34 Zemunska Street, Novi Beograd, Republic of Serbia, reg.no. 17158015, by purchase of shares.
