Council of the Commission for Protection of Competition, pursuant to Article 22 paragraph 2 of the article 25, paragraph 1, Article 57, paragraph 1 and Article 68, paragraph 1, item 4) of the Law on Protection of Competition ("Official Gazette of the Republic of Serbia", number 51/09 and 95/13), and Article 3 and 4 of the Regulation on the criteria for determining the amount to be paid based on the measure of protection of competition and the procedural penalty, the method and terms of their payment and the conditions for determining those measures ("Official Gazette of the RS", number 50/2010), deciding in the procedure conducted ex officio against the Pharmaceutical Institution "Janković" Novi Sad, with headquarters at Miloša Bajić 13, Novi Sad, Republic of Serbia, represented by lawyer Milan Miljuš, PO Box 62, Novi Sad, for the purpose of examining the permissibility of the concentration that was carried out and not approved in accordance with the Law on the Protection of Competition, at the 69th session held on December 24, 2021, passed the following

DECISION

I IT SHALL BE ESTABLISHED that the concentration resulting from the acquisition of individual control by the Pharmaceutical Institution "Janković" Novi Sad, with headquarters at Miloša Bajića 13, Novi Sad, Republic of Serbia, registration number 08289948, over the business of the health institution Apoteka Zrenjanin, with headquarters at Patrijarha Pavla no. 46/c, Zrenjanin, Republic of Serbia, registration number 08671621, which refers to the performance of pharmaceutical activities in the City of Zrenjanin, carried out without prior approval for the implementation of the concentration by the Commission for the Protection of Competition.

II IT SHALL BE ESTABLISHED that the concentration referred to in paragraph I of the enacting terms of this Decision, meets the conditions of permissibility referred to in Article 19 of the Law on Protection of Competition.

III A COMPETITION PROTECTION MEASURE IS HEREBY DETERMINED for the market participant, the Pharmaceutical institution "Janković" Novi Sad, with headquarters at 13 Miloša Bajića Street, Novi Sad, Republic of Serbia, ID number 08289948, in the form of an obligation to pay a sum of money in the amount of 2,939,647.00 (two million nine hundred and thirty-nine thousand six hundred and forty-seven) dinars.

IV Market participant, the Pharmaceutical institution "Janković" Novi Sad, with headquarters at the address 13 Miloš Bajića Street, Novi Sad, Republic of Serbia, registration number 08289948, **HAS BEEN ORDERED** to pay the monetary amount of the competition protection measure from paragraph III of the enacting clause of this decision to the account of the Budget of the Republic of Serbia number 840 743224 843 94, ref.no. 97 - with reference to the number: two-digit control number according to ref.no. 97 - the three-digit number of the municipality, city or territory - the number of this decision.

V A DEADLINE SHALL BE SET to the market participant, the Pharmaceutical institution "Janković" Novi Sad, with headquarters at the address 13 Miloš Bajića Street, Novi

Sad, Republic of Serbia, of 6 (six) months from the date of delivery of this decision for the execution of order from paragraph IV of the wording of this decision under threat of enforcement implemented by Tax Administration in line with regulations prescribing tax collection.

VI The market participant, the Pharmaceutical institution "Janković" Novi Sad, with headquarters at the address 13 Miloš Bajića Street, Novi Sad, Republic of Serbia, reg.no. 08289948 **SHALL BE ORDERED**, within 5 (five) days from the date of execution of the order referred to in paragraph V of the enacting clause of this decision, submit proof of the payment made to the Commission for the Protection of Competition.
