## DECISION

**I APPROVING** in summary procedure the concentration of market participants resulting from the acquisition of joint control of the companies Auto Čačak trucks doo, with headquarters at Braće Stanića 45, Čačak, Republic of Serbia, registration number 21365254; Auto Makiš d.o.o.
