President of the Commission for Protection of Competition, pursuant to Article 35 paragraph 2 and Article 62 paragraph 2 of the Law on Protection of Competition (“Official Gazette of the Republic of Serbia”, number 51/09 and 95/13), and Article 2 paragraph 1 item 7 of the Tariff on the level of compensations for activities within the competence of the Commission for Protection of Competition (“Official Gazette of the RS”, No. 49/11), in deciding upon notification of concentration number 6/0-02-519/2023-1, submitted on June 6, 2023 by Atlantic Grand d.o.o. Beograd, seated at 6a Surčinska Street, Belgrade, Republic of Serbia, through its holder of power of attorney lawyer Milica M.Subotić, from Subotić & Jevtić Law Office, 31, II/8 Terazije, Belgrade, Republic of Serbia, on November 10, 2023, adopts the following

CONCLUSION

I THE PROCEDURE IS HEREBY CONTINUED EX OFFICIO following the notification of the concentration of market participants resulting from the acquisition of individual control by the commercial company Atlantic Grand doo Beograd, seated at 6a Surčinska Street, Belgrade, Republic of Serbia, registration number 17173006, over the company Strauss Adriatic doo Šimanovci, seated at 41 Miloš Obilić Street, Šimanovci, Republic of Serbia, ID number 06299997, by purchasing shares, for the purpose of examining whether the reported concentration meets the conditions of permissibility referred to in Article 19 of the Law on the Protection of Competition, i.e. whether the implementation of this concentration would significantly restrict, distort or prevent competition on the market of the Republic of Serbia or part thereof, and especially if such restriction, distortion or prevention would be the result of the creation or strengthening of a dominant position.

II ALL PERSONS having documents or other relevant information that can contribute to establishing the factual situation in this procedure **ARE HEREBY INVITED** to submit them at the address of the Commission for Protection of Competition, 25 / IV Savska Street, Belgrade.

III THE OBLIGATION of the applicant for the concentration application, Atlantic Grand doo Beograd, seated at 6a Surčinska Street, Belgrade, Republic of Serbia, to pay the amount for the issuance of the decision on the approval of the concentration in the investigation procedure of XXX euros or the dinar equivalent of the said amount calculated at the middle exchange rate of the National Bank of Serbia valid on the day of payment **IS HEREBY ESTABLISHED**, whereas the paid amount of XXX is included therein, and the applicant, the company Atlantic Grand doo Beograd, is **ORDERED** to pay the remaining amount of XXX euros or the dinar equivalent of the said amount calculated at the middle exchange rate of the National Bank of Serbia valid on the day of payment, to the account of the Commission for the Protection of Competition, with reference to number 6/ 0-03-769/2023-1, within 15 (fifteen) days from the date of receipt of the Conclusion.

IV This decision shall be published in the “Official Gazette of the Republic of Serbia” and webpage of the Commission for Protection of Competition.
