President of the Commission for Protection of Competition, pursuant to Article 37 paragraph 2 and Article 65 paragraph 5 of the Law on Protection of Competition (“Official Gazette of the Republic of Serbia”, number 51/09 and 95/13), and Article 2 paragraph 1 item 6 of the Tariff on the level of compensations for activities under the competence of the Commission for the Protection of Competition (“Official Gazette of the RS”, number 49/11), deciding on the concentration report number 6/0-02-669/2023-1, which was submitted on September 15, 2023, filed by Ford Motor Company with headquarters at American Road, Dearborn, Michigan, United States of America, BMW (US) Holding Corp., with headquarters at 300 Chestnut Ridge Road, NJ, Woodcliff Lake, United States of America and American Honda Motor Co., Inc., with headquarters at 1919 Torrance Blvd, Torrance, 90501 California, United States of America, through the attorney, lawyer Danijel Stevanović, from law office Moravčević Vojnović and partners AOD, Bulevar vojvode Bojovića 6-8, Belgrade, on March 14, 2024, brings the following

DECISION

I APPROVING in summary procedure the concentration of market participants related to the joint venture by the companies Ford Motor Company, with registered office at One American Road, Dearborn, Michigan, United States of America, registration number 38-0549190, BMW (US) Holding Corp., with registered office at 300 Chestnut Ridge Road, NJ, Woodcliff Lake, United States of America, registration number 22-2013053, and American Honda Motor Co., Inc., with registered office at 1919 Torrance Blvd, Torrance, 90501 California, United States of America, registration number 0377249, establishing a company called ChargeScape, which is engaged in the provision of network services to electricity transmission and distribution companies and system operators, through a platform related to smart battery management in electric vehicles and smart load management and aggregation of energy data from electric vehicle batteries and which will operate in the United States and Canada, on a long-term basis and have all the functions of an independent market participant.

II IT IS HEREBY ESTABLISHED that the notifying parties, the companies Ford Motor Company, BMW (US) Holding Corp and American Honda Motor Co, on March 11, 2024, paid the amount of XXX dinars to the account of the Commission for the Protection of Competition, which is the prescribed amount for the issuance of the decision on the approval of the concentration in summary procedure.
